Grant of a conditional certificate

bluesign® COMPANY ASSESSMENT was performed for company's production site Has Etiket Tic. ve San. A.S

Mimar Sinan Cad. Ünverdi Sk. No:50, 34540 Günesli-Bagcilar/Istanbul, Turkey on September 25, 2024 by Julian Wade. The resulting roadmap for remedy of the detected nonconformities was discussed and agreed on October 30, 2024.

Remedy of the nonconformities follows the agreed roadmap schedule and could not be completed before expiry of the previous certificate. In order to allow Has Etiket Tic. ve San. A.S to regain compliance with the bluesign® CRITERIA, existing certification remains conditionally valid until agreed roadmap due date.
